

**SPORTSMAN'S COUNTRY CLUB**  
**2018 GOLF OUTING APPLICATION AND AGREEMENT**

1. A valid credit card must be provided to guarantee bookings for your guests on the applicable date and time of your event. The posted credit card can be used for full payment of the event, and/or will be held accountable for no-show penalties and any additional charges prior or during the event.
2. A final guaranteed attendance for your function must be received by Sportsman's 48 hours prior to the event. This guaranteed attendance number must be a minimum of 8 players and is not subject to reduction after the 48 hour deadline. If we do not receive a final guaranteed attendance figure for your golf function by the deadline, you will be charged for the last updated number of person on the agreement, or the actual attendance, whichever is greater. Applicable fees will be charged to the credit card on file.
3. Golf equipment and other auxiliary services provided for your function may carry an additional charge. Each player must their own golf bag & clubs to play at sportsman's Country Club. Sportsman's does have rental clubs available for a fee of \$30 for 18 holes and \$15 for 9 holes
4. Soft spikes are required to play at Sportsman's Country Club. Spikes can be changed for a cost of \$10.00 per pair. No hard-soled shoes are allowed.
5. Appropriate attire must be worn on the golf course, and throughout the facilities of the Northbrook Park District. Men are suggested, but not required, to wear a collared shirt. Absolutely no cut offs, tank tops, spaghetti straps, or bikini tops. Players arriving with unacceptable attire will be required to change prior to tee off.
6. All participants in events at Sportsman's Country Club will be required to uphold the standards of our pace of play program. The expected 18-hole pace of play is 4 hours and 10 minutes and East 9 pace of play is 2 hours and 10 minutes. Sportsman's holds the right to move or remove any players failing to abide by our course rules, pace program, or anyone participating in misconduct on the property.
7. In the event of inclement weather, pro-rated rain checks will be issued to credit you for golf have not completed. Any special orders that were placed and any perishable food items contracted through Sportsman's Country Club will be your responsibility. All golfers are responsible for damages caused by their golf ball, clubs, other equipment, and misuse of the golf car.
8. All food and beverage consumed on the property must be purchased and served by Sportsman's Country Club. There are absolutely no exceptions to this rule, and any food and beverage brought from outside the course without prior permission will be confiscated at the owners loss.
